Dear Don and Board Members:

Since our last presentation before the Planning Board on December 6, 2023, the Town Board was in the process of approving a moratorium that would affect our Application of a (6) Lot Subdivision. The Town Board acted on the Local Law No. 8 of 2023, revised 2-28-24 on March 13, 2024 and approved the Law.

At this time I would like to amend our Application to a (4) Lot Residential Subdivision.

I would like to address the comments of the December 5, 2023 letter from Fusco Engineering and Land Surveying in numerical order:

- 1. OCDOH approval is required. Upon receiving preliminary approval, we will submit to the OCDOH.
- 2. Storm water report was stamped and sent to Fusco Engineering and Land Surveying and is included as an attachment with this submission.
- 3. OCDPW approval is required. I believe the Town has sent it to the OCDPW and I will review status (no change to Lot 3 occurred).
- 4. A Long Form EAF will be submitted with this submittal.
- 5. Note 2 on page 2 has been corrected.
- 6. Title Blocks have been revised.
- 7. The Plans are in conformance with the 25' buffer from wetlands.
- 8. A Legend has been added.
- 9. Water main along Well Sweep Lane has been removed since Lot 5 and Lot 6 are eliminated.
- 10. Cleanouts have been added on Lot #4 gravity sanitary line.
- 11. Area of disturbance has been added.
- 12. See note 4 comment above.
- 13. See notes on Sheets 2 of 5 and 3 of 5.
- 14. L.S.E has been added.
- 15. Sewer line has been revised on Lot 4.
- 16. Roof drains are shown, proposed dwelling are slab on grade.

- 17. Flush hydrant detail to be reviewed by Town of Chester Water Department.
- 18. Lot 4 will require a Wetland Disturbance Permit.
- 19. This was discussed at the Planning Board meeting with no final decision.
- 20. No driveway culverts proposed except Lot 3.
- 21. Sight distances are shown.
- 22. No culvert known under access drive.
- 23. Was shown as 18" hdpe.
- 24. See comment 3 above.
- 25. Stream classification; see note 8 on Sheet2, Class C.
- 26. Stream Crossing Permit is not required on a Class C stream,

We would like to be placed on the April 3, 2024 Planning Board agenda to further discuss this project.
