# TOWN BOARD MEETING August 23, 2023 7:00 PM

Supervisor Valentine opened the meeting at 7:00pm followed by a salute to the flag. Members present: Supervisor Valentine, Councilman Ardisana, Councilman Courtenay, Councilman Holdridge, Councilwoman Smith

Also present: Al Fusco, Fusco Engineering

### **PUBLIC COMMENTS**

E.J. Szulwach, 9 Elm Street, thanked the Board for the formation of the Climate Change Advisory Committee to which he has applied and asked that the Board act promptly to make their selections.

Tom Becker, 163 Lehigh Avenue, asked if the Board had an opportunity to walk the Palmer property that they would be purchasing through the OCLT, how it would be utilized and the cost to the taxpayers to acquire. Supervisor Valentine replied the property would be taken as parkland and provide a trailhead for Goosepond and Sugar Loaf Mountain and allow for parking and direct access. The property has a water feature for sportsmen. Mr. Becker stated it is great to preserve open space but there could be a home developed on the property and that Knapp's View is underutilized. He asked the Board to consider this and decipher its full potential to give a better idea to the public.

Larry Dysinger, 46 Odyssey Drive, stated he believed ARPA funds were to be used for all town residents but is being used for the water districts. He said money into the general fund should not be used for water districts so it should be re-imbursed. He asked if the Board started the budget process and what the projected date of the preliminary budget. He asked that the budget include expenses for water and sewer district maintenance and upgrades and the study on water tables. He asked why the interview process is taking four weeks for the comprehensive plan committee. Councilman Holdridge said two interviews were conducted by himself and Councilman Courtenay today and one still remains. Mr. Dysinger said it has been seven months since its creation and asked why it takes so long to get things done. He added that once the Board makes a commitment, the residents should expect them to be responsive.

Howard Cohen, suggested the Board reach OCLT come in to answer questions.

Lisa Hintze, Central Valley Climate Task Force said it is a lot of work but so important. In their first year, they have held seminars on ground water, provided information on pollinator pathways and monarch stations. They have conducted Arbor Day and Earth Day tree plantings, composters, sold rain barrels, unified solar permitting, spring and fall clean-ups, repair café, and farmer's market. She said Chester should treasure their resources such as the parkland about to be purchased.

Lydia Cuadros, 158 Creamery Pond Road, asked if the Town would be completing the resurface of Creamery Pond with asphalt. Supervisor Valentine said the road was scheduled to be tarred and chipped.

Chris Mauer, 43 Creamery Pond Road, commented that it is cheap, looks horrible, causes a lot of dust and the children cannot ride bikes. Supervisor Valentine said the Highway Superintendent submits his expenses for planned work in his budget and that the road would compact over time.

Councilwoman Smith read the letter received from the NYS Town Clerk's Association and offered her congratulations to Town Clerk Zappala on the designation of Registered Municipal Clerk. Supervisor Valentine added the Clerk does her job really well and goes above and beyond, as they have worked together over the many years.

# APPROVAL OF PARKLAND PURCHASE THROUGH ORANGE COUNTY LAND TRUST

Supervisor Valentine read the letter received from the Orange County Land Trust offering 10.4 acres of land located on the east side of Laroe Road for \$300,000 as designated parkland. Conditions include:

- Final subdivision approval of the subdivision of Lot 35.2 by the Town of Chester Planning Board.
- OCLT'S acquisition of approximately 300 acres of land owned by two LLC's controlled by the Palmer family.
- Approval of the sale by the OCLT Board.
- Approval of the purchase by the Town of Chester Board.

**ON A MOTION OFFERED BY** Councilwoman Smith and second by Councilman Holdridge to approve the purchase contract from the Orange County land Trust in the amount of \$300,000 subject to terms.

DISCUSSION: Councilwoman Smith that it would provide access to trails, ponds for fishing, possible pavilion and valuable as a lot of land is sold off privately. Councilman Courtenay said it is part of the comprehensive plan. Supervisor Valentine said it could be paid out of fund balance or use part of ARPA funds, and parkland funds with the possibility of some funding from our state representatives.

# GREENS OF CHESTER TRANSPORTATION CORPORATION FOR INFRASTRUCTURE

Supervisor Valentine explained that before the Town takes over the water and sewer districts, The Greens will develop and operate the system until it is substantially complete and the transportation corporation holds all the infrastructure for the interim. Engineer Fusco stated upon project approval, bonds were taken and inspections up to date. Orange County Health Department approval is subject to formation of the transportation corporation, which takes into account the service areas. State law requires approvals provided to water authority, which is Orange County. The resolution, with no objections of the Department of Health and Town review to adopt the transportation corporation, required by DEC and pending legal review goes to the OCDOH and NYSDOH. Councilman Courtenay asked what the timeframe is for takeover by the Town. Al Fusco replied it remains private until almost built out, then the Town will take over within three months of a public hearing. Supervisor Valentine stated the Town is obligated to approve the Transportation Corporation.
