SPECIAL TOWN BOARD MEETING November 14, 2023

6:30 PM

Supervisor Valentine called the meeting to order at 6:30pm followed by a salute to the flag. Members present: Supervisor Valentine, Councilman Courtenay, Councilman Holdridge, Councilwoman Smith, ABSENT: Councilman Ardisana

PUBLIC COMMENTS

Larry Dysinger, 46 Odyssey Drive asked that the Board keep him and Tom Becker apprised of the developments with the Teamsters union.

E.J. Szulwach, 9 Elm Street, asked how much money was considered for the Climate Change Committee and where it is in the budget. Supervisor Valentine replied there is no specific line item but the expenditure could come out of Town Board or Town Supervisor's funds as discretionary spending, or may also be eligible for ARPA funding.

Tom Becker, 163 Lehigh Ave., asked whether there was funding for the sewer slip lining infrastructure project in Surrey Meadows. He said there was the ability to link onto another community's bid for \$30,000 to get the work complete. Supervisor Valentine replied there was nothing in the budget other than the Moodna Commission's budget.

LOCAL LAW NO. 7 OF 2023 – A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C

ON A MOTION OFFERED BY Councilman Courtenay and second by Councilman Holdridge,

Be it enacted by the Town of Chester in the County of Orange, as follows:

Section 1. Legislative Intent

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Chester, County of Orange, State of New York (hereinafter "Chester") pursuant to General Municipal Law §3-c, and to allow Chester to adopt a town budget for (a) town purposes and (b) any other special or improvement district governed by the Town Board for the fiscal year 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Chester is hereby authorized to adopt a budget for the fiscal year 2024 that requires a real property tax levy in excess of the limit specified in General Municipal Law §3-c.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or

corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

2024 BUDGET ADOPTION

Supervisor Valentine explained there were line items missing for some of the water districts, and so he provided an amendment to those sections. The cover sheet changed because some of the numbers changed, but the budget remained the same. He removed the garbage district from the tax cap, which became problematic because the tax cap was reduced since he had to refile and remove it from last year's budget as well. He continued to explain that the 2023 budget of \$15,546,159 used \$600,000 in fund balance to balance the budget but the bookkeeper inadvertently deducted \$600,000 twice from the amount to be raised by taxes on the summary sheet, which is used by the County to calculate the tax collected. This year we are really over the cap by \$300,000 but it has had a snowball effect. He said he had to resubmit the garbage and reserve funds error to correct and will make sure it doesn't happen again this year. Councilman Holdridge asked about the changes in the water districts' budgets. Supervisor Valentine replied that 8330.2 purification was added to Sugar Loaf, Surrey Meadows and Lake Hill Farms. Councilman Holdridge questioned the \$1,027,279 of unexpended fund balance used. The Supervisor directed him to the bottom of each fund for the amount of fund balance used. He said he used some drainage districts funds as a credit back. Councilman Holdridge asked if the Edmunds service was used to create the budget. Supervisor Valentine answered that the bookkeeper would have entered the information into Edmunds but it was not possible with the current situation in the staffing. He concluded it is a good solid budget with the underestimates of sales and mortgage tax and reduced court fines and the Town won't run out of funds next year. Councilman Holdridge said he would have liked to have more time to double check the budget before the vote.

ON A MOTION OFFERED BY Councilman Courtenay and second by Supervisor Valentine to adopt the 2024 Town of Chester Budget.

Councilwoman Smith said she didn't feel comfortable to vote to approve the budget. Councilman Holdridge said in the best interest of the residents, if Councilwoman Smith would not change her vote he would approve with major reservations. The motion was then put up for a vote.

ON A MOTION OFFERED BY Councilman Courtenay and second by Councilman Holdridge to adopt the 2024 Town of Chester Budget.

TOWN HALL EMPLOYEE UNION

RESOLUTION

A meeting of the Town of Chester Town Board was convened on November 14, 2023 at 6:30 p.m.

The following Resolution was duly offered and seconded to wit:

RESOLUTION AUTHORIZING RECOGNITION OF TOWN WHITE COLLAR BARGAINING UNIT

WHEREAS, on June 9, 2022, Teamsters Local 445 ("Local 445") file a petition for recognition for certain Town employees, including the titles of full and part-time account clerks, administrative clerk, benefit and bookkeeping administrators, clerks, court clerks/ clerks to the Town Justice, deputy court clerks, deputy town clerks, senior clerks, senior-clerks highway, senior secretary, supervisor's secretary, account clerk-typists, planning and zoning clerks, assessor's clerks, recreation aides and typists; and

WHEREAS, proceedings before the New York State Public Employment Relations Board ("PERB") were held concerning recognition of such until; and

WHEREAS, the proposed titles of the Confidential Secretary to the Supervisor (also referred to as "Supervisor's Secretary") and Senior Secretary were withdrawn from the proposed unit by Local 445 as managerial/confidential; and

WHEREAS, certain titles petitioned for were incorrectly described in the petition and were not titles existing in the Town; and

WHEREAS, the matter otherwise remains pending before PERB following a hearing; and

WHEREAS, the Town Board desires to withdraw opposition to the pending petition for recognition for the remaining titles that are the subject of the PERB proceeding and exist in the Town.

NOW THEREFORE BE IT RESOLVED that:

Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.

Section 2. The Town Board hereby authorizes the recognition of the Town White Collar Bargaining Unit ("Unit") and Local 445 as representatives of the employee titles petitioned for (or substantially similar civil service titles) with the exception of the Confidential Secretary to the Supervisor and Senior Secretary which titles will remain outside the bargaining unit.

Section 3. The titles recognized by the Town for inclusion in the unit are:

Assessor's clerk Account Clerk Account Clerk Typist

Benefits & Bookkeeping Administrator

Clerk

Clerk To Town Justice Deputy Court Clerk Deputy Town Clerk Recreation Aide

Secretary to the Planning Board

Senior Clerk Typist

Section 4. The Town Board hereby authorizes the Town Supervisor to take any and all actions necessary to formalize the recognition of the Unit, including but not limited to any required publication pursuant to the PERB Rules.

<u>Section 5.</u> The Town Board hereby authorizes the Town Supervisor and Deputy Supervisor Cindy Smith to negotiate an initial Collective Bargaining Agreement with the Unit and to finalize the agreed upon

list of titles to be recognized if any discrepancies arise. The proposed Collective Bargaining Agreement shall be subject to final review and approval by the Town Board and the Town's legal counsel.

Section 6. The Town Supervisor and any Town official, employee or consultant, as directed by the Town Supervisor, is hereby authorized and directed to take any necessary and appropriate actions to carry out the provisions of this Resolution.

<u>Section 7</u>. This Resolution shall be effective immediately.

Discussion: Councilman Courtenay asked about the Comptroller's position. Supervisor Valentine explained that the position of Comptroller would not be included in the union as it is an appointment and department head position. He added that the objection was the PERB filing being inaccurate and not filed very well, but contract is subject to Town Board approval. Councilman Holdridge asked if the negotiations would begin this year. The Supervisor replied he doesn't know how long it will take but will start with the union making a proposal and then it would go back and forth.
