# Section 1. Purpose and Intent

It is the intent and purpose of this Local Law to update and amend Chapter 33 of the Town Code of the Town of Chester, entitled "Alcoholic Beverages and Cannabis", to add provisions which prohibit smoking, vaping and the use of electronic cigarettes on public property located in the Town of Chester. It is the finding of the Town Board of the Town of Chester that smoking, vaping, and the use of electronic cigarettes on public property owned by the Town of Chester is detrimental to the health, safety and welfare of the citizens of the Town of Chester, and that such public use contributes to the creation of nuisances and otherwise impedes upon the welfare of Town residents. The Town of Chester enacts this local law an exercise of its police power to promote the general health, safety and welfare of the residents of the Town of Chester.

Said public hearing will take place in the Town Hall Meeting Room, 1786 Kings Highway, Chester, NY on Wednesday, August 9, 2023, at 7 PM or as soon thereafter as the matter may be heard.

ADOPTED

Joshua Kopf supports the local law. He reported the CDC estimate of 1/5 of the population as impacted by second-hand smoke. With 8% of Americans with asthma, 5.6% with COPD and 100-200,00 with lung cancer, he stated there is no safe exposure. He said his brother and girlfriend have asthma and when at public places worry about the risk of having an asthma attack due to second-hand smoke, creating undue hardship. Orange County's 9.3% of asthma related hospital visits is double the State average. He said the law will make Chester safer for everybody who calls it home.

Howard Cohen supports the local law. He stated the US Surgeon General reported back in 1972 that second-hand smoke was dangerous. He read excerpts from various health organizations regarding second-hand smoke, including the National Institute of Health stating harmful and deadly; CDC - 7,000 chemicals in tobacco smoke including toxic chemicals; EPA - there is no safe level of second-hand smoke whether in or outdoors. He quoted statistics:1,400 deaths in NYS annually from heart disease, cancer and strokes from smoke-related exposure, and effects on children such as ear infections, wheezing, breathing issues. He referred to NYS 50-year study of 100,000 health-related deaths in babies exposed to second-hand smoke. He made reference to the Town's cannabis prohibition local law which was founded as a detriment to the public. He said it behooves us to add smoking to that list.

Cheryl Kopf thanked the members for their service, and supports the local law. In addition to the health risks, she addressed the uncomfortable smell caused by smokers outside of buildings. She stated the loss of her father to lung cancer and relatives who are asthmatic subject to the habits of others who are infringing on their rights. She said it is hard to see children exposed to second-hand smoke in public places. As an educator, mother, and concerned citizen she supports the law that people should not smoke in public places.

# Section 2. Amend and Replace Chapter 33, Entitled, "Alcoholic Beverages and Cannabis", to Read:

Chapter 33. Alcoholic Beverages, Cannabis, Smoking, Vaping and Electronic Cigarettes.

### Section 3 Add Article III, to Read:

Article II. Smoking, Vaping, and Use of Electronic Cigarettes on Town Property.

# §33-10. Legislative Findings.

The Town Board of the Town of Chester finds that smoking, vaping, and the use of electronic cigarettes on public property owned by the Town of Chester is detrimental to the health, safety and welfare of the citizens of the Town of Chester, causes hazardous, unsightly and unsanitary conditions, and creates a public nuisance.

#### §33-11. Definitions.

#### **ELECTRONIC CIGARETTE**

As used in this Article, "Electronic Cigarette" or "E-Cigarette" shall mean an electronic device that delivers vapor which is inhaled by an individual user, and shall include any refill, cartridge and any other component of such a device. This shall also have the same meaning as defined in New York State Public Health Law §1399-n, as may be amended from time to time.

#### PUBLIC PROPERTY

As used in this Article, Public Property shall mean any highway, street, sidewalk, park, playground, municipal-owned building or public parking lot.

#### **SMOKING**

As used in this Article, Smoking shall mean the burning of a lighted cigar, cigarette, pipe or any other matter or substance which contains tobacco. This shall also have the same meaning as defined in New York State Public Health Law §1399-n, as may be amended from time to time.

#### VAPING

As used in this Article, Vaping shall mean the use of an electronic cigarette. This shall also have the same meaning as defined in New York State Public Health Law §1399-n, as may be amended from time to time.

# §33-12. Prohibited Acts.

No person shall smoke and/or vape any tobacco substance using any device or method including, but not limited to, cigarettes, cigars, Electronic Cigarettes and pipes on any Public Property within the Town of Chester.

# §33-13. Penalties for Offenses.

Each violation of this Article shall constitute an offense punishable by a civil penalty of up to \$200, at the discretion of the Town of Chester Justice Court.

# Section 6. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 7. Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.

#### DISCUSSION:

Deputy Supervisor Smith said there should be more discussion before adoption.

Councilman Courtenay agreed to align the law with the cannabis prohibition, although he thought that a 50-75ft distance from the building would have been allowed. Attorney Bonacic said the introductory law does not allow smoking at all on public property. Councilman Courtenay said we heard from the residents we represent.

Deputy Supervisor Smith stated the law should be amended for distance to allow for smoking in designated areas outside the theater, when court is in session, and highway employees.

Councilman Holdridge said we heard from the people and since the Board voted the same on marijuana prohibition when cigarette smoking is more dangerous, he believes it should be prohibited.

Councilman Ardisana said although there are certain rights of smokers he agrees with the law as written.

# Section 2. Amend §87-9, Subsection (A), Paragraph (4), to read as follows:

§87-9. Exemption Granted

A. Any qualified member who has been certified by the authority having jurisdiction (hereinafter the "AHJ") for the incorporated volunteer fire company, fire department or volunteer ambulance service as an enrolled

member of such incorporated volunteer fire company, fire department or volunteer ambulance service shall be entitled to a 10% reduction in the taxable value of their real property for Town real property tax purposes so long as:

4) The applicant has been an enrolled member of incorporated volunteer fire company, fire department or volunteer ambulance service for at least 2 years prior to submitting an application for tax exemption; and

# Section 3. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

# Section 4. Effective date.

#### CLIMATE CHANGE ADVISORY COMMITTEE

Councilman Holdridge said following numerous requests and to affect positive change he proposes the formation of a Climate Change Advisory Committee. The Climate Change Advisory Committee will comprise of interested members (around 5-10) of the community and a liaison from the Town Board. The committee's goal is to study the town's internal policies and code in order to figure out how, if any, improvements could be made to further contribute to climate change prevention. Although some practices in Chester have been already been made towards that end, some members of the community and myself, feel that there is no reason to not explore more opportunities to curb our own contributions to the worsening condition of the planet's climate. The committee will be able to speak with town department heads, employees, and elected officials as well as request any internal documents in order to thoroughly review our practices and then advise any town entity as well as the Town Board on how they could improve on themselves. The committee will physically meet no less than four times a year (unless extenuating circumstances prevent it), but they may meet as often as they see fit.

Police Department Report – July 2023

The Town of Chester Police Department stayed active in the community again last month. We maintained our objective of community commitment and continued to take a proactive stance towards detecting crime and enforcing the laws. In July, the police department responded to 344 calls for service. Officers patrolled for 14,889 miles during the month.

# **COMMUNITY POLICING**

During the month, Town of Chester police officers assisted members of the community in many ways. Some of the community policing activity is listed below.

Officers completed 50 house security checks and 1096 business security checks.

Sergeant Dugan and Officers Bird, Weinstein, Stack and Narain continue to remain available for child passenger safety seat checks and installations.

Officers were assigned to foot, bicycle and vehicle patrols during the town's annual Fireworks Event held in the village on July 8<sup>th</sup>. Officers were also assigned to traffic posts at the conclusion of the event to assist guests leaving the area.

#### **TRAINING**

Monthly training for July was a refresher course in Standardized Field Sobriety Testing taught by Del. Grosso from the Village of Chester PD. It was held at the senior center on July 17<sup>th</sup> and July 27<sup>th</sup>. All full-time officers and sergeants except SRO Perez (vacation) attended on one of the dates.

Our semi-annual firearms training concluded in July at the range in Port Jervis. All officers have completed spring training with instructors Sgt. D'Agnese and Officer Calderone.

Sgt. Chambers attended a webinar on July 12<sup>th</sup> on the Most Common Pitfalls in the Accreditation Process. Chief Doellinger watched a recording of the same webinar later in the month.

#### **MISCELLANEOUS**

Commercial vehicle enforcement details were held on July  $7^{th}$  and  $21^{st}$  with the NYS Department of Transportation. Fifteen vehicles were inspected and two unsafe vehicles were taken out of service with major violations.

Tactical Response Unit officers assisted Monroe PD with their fireworks event on July 7<sup>th</sup>.

Part-time Officer Michael Lawrence continued his field training in July.

# Water Department – July 2023

The water department processed and distributed 6,620,017 gallons of water for the month of July. The districts daily average ranged from 436 to 66,000 gallons. The breakdown is:

Lake Hill Farms- 2,047,000 gal. Sugar Loaf- 1,473,100 gal. Surrey Meadows- 1,546,100 gal. Walton Lake Estates- 1,323,200 gal. Fieldcrest- 217,074 gal. (Distribution only) Town Hall- 13,543 gal.

Distribution sampling by us as well as random sampling by Orange County DOH showed adequate disinfection levels, and tested negative for any type of bacteria.

Monthly DOH 360 forms and test results for 6/2023 on all districts were submitted to DOH on 7/5/2023.

Laboratory testing dates were 7/5 & 7/19.

Mowing dates at the plants were 7/6, 7/25 & 7/31.

Bulk chemicals were delivered on the 28th.

Picked up Chlorine at All Gas 7/1.

Replaced front brakes on F150.

#### Other Business:

Sugar Loaf was mostly quiet with routine operations and maintenance. 7/6 Quackenbush came in to lower well 1A down 100ft for stepdown test. Underwater Solution 7/11 replaced anodes at water storage tank. 7/17 WSP started 72hr step down test at well 1A at 80gpm. Pump test creating too much drawdown of private wells. cancelled test to start over at lower gpm in few weeks. 7/31 WSP started new 72hr step down test at well 1A at 66gpm.

Surrey Meadows was mostly quiet with routine operations and maintenance.

Lake Hill Farms was mostly quiet with normal operations and maintenance. Underwater Solutions cleaned and inspected welded storage tank 7/12. TAM 7/12 came and replaced broken radio system at plant and tower. Underwater Solution 7/13 replaced anodes on the new water storage tower. 7/26 repaired shutoff at 51 Lincoln with help from vac truck from Monday. 7/31 we painted the outside of the water plant building.

Walton Lake Estates was mostly quiet with routine operations and maintenance. Call out 0n 7/2 for water in the house from PD for 8 Tulip. Put in a service shut off at 8 Tulip with help from Hwy Dept to determine leak is homeowners' responsibility. 7/10 Water main break at 19 oak Dr, new wrap around help from Hwy Dept. Underwater solutions came in 7/10 to do storage tank cleaning. Dropped off spare booster motor off to get rebuilt as a backup 7/19. 7/24 replace 3" pipe in the plant due to a leak. 7/28 cleaned up plant of brush and over grow.

Fieldcrest was quiet with routine operations and maintenance. Replaced backflow valve at parks bathroom 7/20.
