Members present: Supervisor Jamieson, Councilman Murray and Councilman Valentine. Absent: Councilwoman Smith.

APPOINTMENTS

A motion was made by Councilman Murray and seconded by Councilman Valentine to appoint Linda Ranni as a Town Board member for the period ending December 31, 2014. Motion carried 3-0.
