DECLARATION OF STATE OF EMERGENCY TOWN OF CHESTER

I hereby direct all departments of the Town of Chester, to take steps necessary to protect life and property, public infrastructure, and provide such emergency assistance deemed necessary.

This state of emergency has been declared due to the ongoing COVID-19 / Coronavirus Disease 2019, which was declared a pandemic by the Centers for Disease Control (CDC) on March 11, 2020, the World Health Organization (WHO) declared this disease a world Pandemic on March 11, 2020, the Governor of the State of New York declared a state of emergency for New York State on March 07, 2020 and on March 13, 2020 the President of the United States filed an Emergency Declaration in regard to COVID-19, is of sufficient severity and magnitude to warrant that certain emergent protective measures to be taken in response to the COVID-19 pandemic emergency to protect the health, safety, and welfare of all the Town residents, pursuant to subparagraph 4 of Section 103 of the General Municipal Law.

These conditions threaten the public safety of the citizens of the Town of Chester.
