#### April 26, 2000

The Township Committee of the Township of Hillsborough met in a Regular Meeting on the above date at 8:00 PM. Those in attendance were as follows: Mayor Joseph Tricarico, Deputy Mayor Christine Jensen, Second Deputy Mayor John Gelardi, Committeewoman Sonya Martin, Committeeman Robert Mack, Township Attorney Emil Philibosian, Administrator John Middleton, and Township Clerk Gail W. McKane.

Following Roll Call and Salute to the Flag, Mayor Joe Tricarico advised that notice of this Regular Meeting was given to the Township Clerk, posted on the bulletin board at Municipal Complex, and written notices sent to the Messenger Gazette, Hillsborough Beacon and the Courier News. All notices were given at least 48 hours in advance, and to the extent known, the items on the agenda.

### **PROCLAMATION:**

Joe Schirmer, Emergency Management Coordinator

Mayor Tricarico stated that he was reading this proclamation with mixed feelings since Mr. Schirmer has contributed a great deal to the Township, but wished him all the best. Mr. Schirmer approached the dais and Mayor Tricarico read the following proclamation:

**WHEREAS**, Joseph Schirmer will step down as Hillsborough Township's Emergency Management Coordinator after more than ten years of dedicated service; and

**WHEREAS**, Joseph Schirmer was appointed as the Emergency Management Coordinator in January of 1989 and during that time has continually displayed professionalism and dedication in this volunteer capacity. Hillsborough Township is an EMA funded municipality, which requires an additional level of participation on the part of the Coordinator and staff. In that regard, Joe's sense of organization and ability to get people involved and participating in the task at hand has been outstanding; and

WHEREAS, Joseph Schirmer has devoted countless hours of his time in developing and maintaining Hillsborough Township's Emergency Management Plan, working with all representatives of the emergency service units within the Township to ensure a proper response to any and all of the many emergency situations within the community and gaining knowledge through training seminars and workshops at the County and State levels; and

**WHEREAS**, Joseph Schirmer's expertise was invaluable in coordinating a response to the Aetna gas explosion in April of 1989, in setting up a command post in October of 1990 when a tornado struck Montgomery Township and for his assistance during the storm of January, 1994 which resulted in power outages and evacuation of a number of residents.

WHEREAS, in 1996, Joseph Schirmer assisted in the trailer fire at Reckitt & Coleman and during a large rainstorm which resulted in extensive flooding. His coordination efforts during the Buckeye Pipeline leak in October of 1997 and during the plane crash in Brookside Square in March of 1998 and another plane crash on a golf course in May of 1999 were also invaluable. Of particular note was his tireless efforts during Hurricane Floyd in September of 1999 protecting the Township during the storm, rescuing numerous residents and for clean-up efforts days afterwards. His organizational abilities were particularly evident in the preparation that took place for Y2K and because of his efforts, Hillsborough took the lead in planning and accomplishing their goals prior to the Y2K event; and

**WHEREAS**, throughout his tenure as Emergency Management Coordinator, Joseph Schirmer has been recognized many times for his efforts. He was given special recognition for his participation in the FEMA level exercise "Response 98" in April of 1998 and he was presented with an Official Letter of Commendation from the Hillsborough Township Police Department in November of 1999 for his years of dedicated service.

**NOW, THEREFORE, BE IT PROCLAIMED** by the Mayor and Township Committee that Joseph Schirmer is to be commended for his years of dedication and service to the Township of Hillsborough and for the valuable contributions he has made to our community.

**BE IT FURTHER PROCLAIMED** that each member of the Township Committee thanks him for a job well done and wishes him continued success in his future endeavors.

Mayor Tricarico presented Mr. Schirmer with the proclamation and a watch and thanked him for his dedication and service to Hillsborough Township.

Deputy Mayor Jensen also thanked Mr. Schirmer and stated that his volunteer efforts showed his responsible citizenship.

Mr. Schirmer replied that it was a team effort and commended Police Captain Robert Roscoe for his work on the Emergency Management Team.

# **ARBOR DAY PROCLAMATION:**

Deputy Mayor Jensen read the following proclamation:

**WHEREAS,** in 1949, the legislature set aside the last Friday of April as Arbor Day to promote the planting of trees and to encourage the protection of our forests from fires and pests that destroy the beauty and usefulness of our woodlands; and

WHEREAS, half of New Jersey's total land area is forested or tree covered; and

WHEREAS, trees play an important role in the ecosystem in which we live, and trees reduce the erosion of our precious topsoil caused by wind and water, clean the air we breathe and the water we drink, produce oxygen, provide a habitat for birds and wildlife and reduce heating and cooling costs by moderating temperature; and

**WHEREAS,** trees are a renewable resource giving us paper for fine literature, wood for homes, fuel for fires, and countless other wood products; and

**WHEREAS,** trees provide increased property value, enhanced economic viability, and pleasing aesthetic qualities along streets and properties in municipalities; and

**WHEREAS,** tree planting in yards and farms, in school yards and parks, and along streets and highways creates an enduring heritage for generations that follow; and

**WHEREAS,** this is the fifty-first anniversary of the State Arbor Day Celebration in New Jersey.

**NOW, THEREFORE, BE IT PROCLAIMED** that we, the Mayor and Township Committee, do hereby declare April 28, 2000, as

**ARBOR DAY** In Hillsborough Township and urge all citizens to support efforts to protect our trees and woodlands and to support our Township's urban forestry program.

**BE IT FURTHER PROCLAIMED** that we urge all citizens to plant trees to gladden hearts and promote the well being of present and future generations.

Deputy Mayor Jensen said that in celebration of Arbor Day, the Mayor will be planting a tree in the Sensory Garden at Ann Van Middlesworth Park at noon on Friday, April 28<sup>th</sup>.

## **ORDINANCE 2000-14**

# AN ORDINANCE APPROPRIATING CERTAIN MONIES HELD BY THE TOWNSHIP OF HILLSBOROUGH COUNTY OF SOMERSET, STATE OF NEW JERSEY FOR THE PURPOSE OF CAPITAL IMPROVEMENTS INVOLVING THE PURCHASE OF A SENIOR TRANSPORTATION BUS, EMERGENCY EQUIPMENT, PUBLIC WORKS EQUIPMENT, AND ROAD OVERLAYS.

**WHEREAS**, there exists in the Hillsborough Township Capital Improvement Fund a sum of \$590,077.78 and in the Fund Balance the sum of \$608.03:

**WHEREAS**, the Hillsborough Township Committee, Deputy Director of Public Works, Chief of Police, Social Services Director and the Township Engineer have determined there is a need to appropriate the aforesaid Capital monies for the following uses and purposes:

- 1) Senior Transportation Bus
- 2) Acquisition of emergency equipment.
- 3) Road overlays.
- 4) Public Works equipment.

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Hillsborough, County of Somerset, State of New Jersey, that Ordinance 2000-14 is hereby appropriating from the Capital Improvement Fund the sum of Five Hundred Sixty Thousand Dollars (\$560,000.00) for the following purposes:

- B. Police equipment and related apparatus -- \$20,500.00

# **REPORTS FROM COMMITTEE LIAISONS:**

# Mayor Tricarico

Mayor Tricarico reported that a Postal Advisory Committee meeting would be held in about 2-1/2 weeks, at which time Hillsborough's new zip code would be released. He encouraged the Postal Advisory Committee to get that information out as soon as possible so that both residents and businesses have time to change addresses and stationery. Mayor Tricarico stated that he would advise the Postal Advisory Committee that the Township would coordinate road name changes with the opening of the new Post Office.

# Deputy Mayor Jensen

Deputy Mayor Jensen stated that she viewed an interesting presentation about the Sourland Mountain region. She advised that the Sourland Mountain region is the largest contiguous forested space in central New Jersey and is one of the last forested areas that is not under significant protection. Deputy Mayor Jensen explained that as a result of development pressure, some of Hillsborough's neighboring communities have completed detailed environmental analyses within the region and not only are there endangered species but there are interesting ecosystems within the region. She asserted that it was important for the Township to consider the required protection of this area.

## **Committeeman Mack**

<u>Resolution hiring Annie Yip as Assistant Control Person in the Building Department, union</u> position, Class 2, Level 1, with a salary of \$26,807.

Committeeman Mack offered a resolution hiring Annie Yip as Assistant Control Person in the Building Department. Seconded by Committeewoman Martin.

**WHEREAS,** there exists a vacancy in the Building Department for the position of Assistant Control person; and

**WHEREAS,** the position vacancy has been posted according to the current AFSCME contract regulations; and

**WHEREAS,** Construction Official Ronald Estepp has received and reviewed numerous applications; and

WHEREAS, Annie Yip appears to be the most qualified for the position; and

**WHEREAS,** Township Construction Official Ronald Estepp recommends the Township Committee take action to hire Annie Yip as an Assistant Control Person in the Building Department, pursuant to Union Contract requirements, as a Class 2 Level 1 position with a 2000 salary of \$26,807.00 for a 40 hour week, effective, May 1, 2000.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Hillsborough that the recommendation of Township Construction Official Ronald Estepp be and hereby is accepted and approved and Annie Yip is hired as an Assistant Control Person pursuant to Union Contract requirements as a Class 2 Level 1 position with a 2000 salary of \$26,807.00 for a 40 hour week, effective May 1, 2000.

Committeeman Mack reported that the Somerset County Historic Preservation Grant Program is in existence and has authorized a second round of applications. He stated that the Somerset County Board of Chosen Freeholders would review the applications and decide which projects to fund. Committeeman Mack advised that applications are due by June 22, 2000. He commented that the Township has a number of projects to fund, one of which is an historic registry for the Township.

Committeeman Mack also mentioned that the Historic Commission has moved forward with "Welcome" signs for the Township. He stated that the Historic Commission has chosen a picture for the signs and Committeeman Mack wanted to get these signs up soon.

Committeeman Mack reported that the Cable Advisory Commission had met recently and some ground rules were established and the next meeting will be May 17<sup>th</sup> at 8:00 PM.

### Committeewoman Martin

Committeewoman Martin stated that last Thursday she had the opportunity to see the Community Pantry in operation. She explained that last Thursday, 43 families came to the multi-purpose room and received food for their holiday. Committeewoman Martin remarked that it was heartwarming to see seven or eight high school students give their time and effort to organize this food drive. She noted that a thank you letter was sent to all religious and youth organizations and individuals that provide food on an ongoing basis for the town's pantry.

Committeewoman Martin reminded everyone that Saturday, May 27<sup>th</sup> the Memorial Day Parade and Picnic would be held. She stated that the Hillsborough Recreation Commission, the Rotary Club and many individual volunteers are working hard to make this a special day. Committeewoman Martin also noted that on June 3<sup>rd</sup>, the US Bicycling Hall of Fame will hold a bike rally that will start in Somerville, proceed through Franklin and into Hillsborough, with a stop at the Municipal Building here in Hillsborough.
