- AREA VARIANCE FOR AN EXISTING FRONT YARD OF 86.6 FEET WHERE THE CODE REQUIRES A MINIMUM OF 100 FEET.

- AN AREA VARIANCE GRANTING RELIEF FROM THE MINIMUM PARKING

SPACES REQUIRED OF 120 AND A REQUEST FOR 69 SPACES.

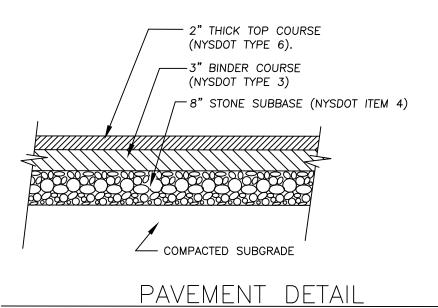


# TYPICAL PERMANENT SIGN INSTALLATION

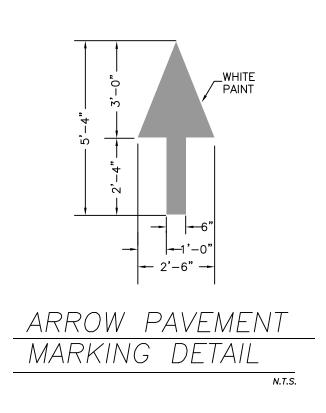

- 5. STOP SIGNS MUST HAVE REFLECTORIZED STRIPS ON POSTS.

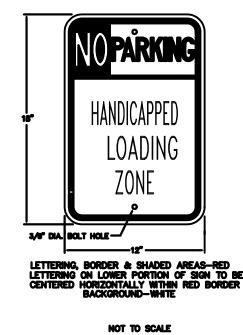


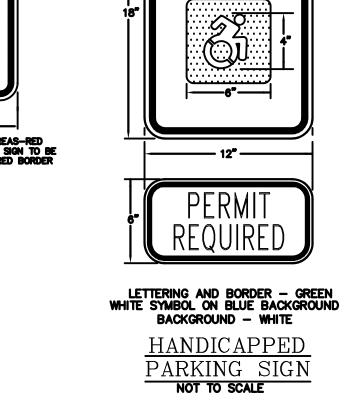

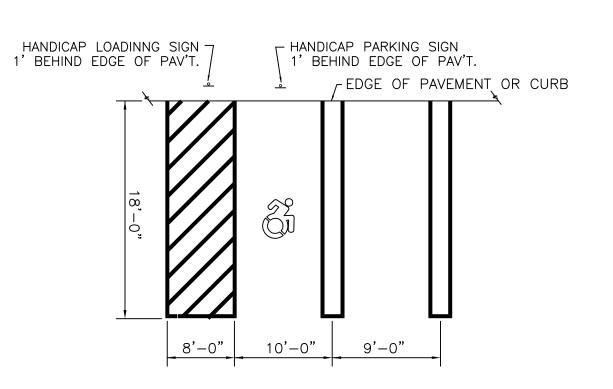


STOP BAR DETAIL
