Lydia Cuadros, via FB, stated that the Sugar Loaf Hills Water District has one good well with an e-coli back-up well and asked how the district will support the Broccoli Patch planned usage of over 1,000,000 gallons of water. Supervisor Valentine said he will get back to her personally and the Town is doing improvements, at this time, in Sugar Loaf.

Supervisor Valentine said he made some changes bringing the budget \$43,000 under the tax cap and by utilizing \$445,000 of fund balance, which has been built up over the past few years, to offset increases in potential retirement costs and the increases in the highway budget due to needed road repairs. Also, summer camp has been added back into the budget. The total budget is coming in at \$15,513,000 and the tax cap allows a 1.004% increase. Councilman Courtenay commented that AARPA money has not been included which could potentially offset some increases.

CODE AMENDMENT PROPOSAL

Councilman Holdridge spoke on the matter of the Ethics Code amendment that was introduced by him on September 14, 2022 and his desire to change the procedure in which the complaints are addressed. He would like them to go directly to the Ethics Board not the Town Board, as is currently the procedure, which he said could cause a conflict of interest and is not a good and efficient way of dealing with the process. He said after he was asked to do research, he looked into other Town and Village codes. The Town of Monroe offered that there has not been a large influx of/or anonymous complaints since their code was implemented and there are only usually two or three complaints a year. The Board Chair in Town of Newburgh has not received a complaint in two years. New Windsor utilizes a form and Cornwall-on-Hudson and Montgomery also use this process. Language is available that can be contorted to our needs. He said it would be a big improvement and does not think it would be an abuse of power since the Ethics Board doesn't make decisions, but makes suggestions to the Town Board who decides and moves forward. He asked for approval to have the Town Attorney draft a local law. Councilman Courtenay opined that Councilman Holdridge's proposal was based on opinion, not fact and any email or messages he received should be shared with the Board. He said he has no interest in changing how it is handled because you don't need to fix what is not broken. He added that the Board is elected because they are ethical. Councilman Holdridge said people have expressed concerns of conflict of interest and if there are no concerns then why would the Board be afraid to change the procedure. Councilwoman Smith said she is not in favor of having complaints changed from filing with the Town Board to the Ethics Board. Councilman Ardisana said we shouldn't give the Ethics Board that much power. Supervisor Valentine said if there was reform it should be to change something broken and if there are no problems there is no need to fix as there has been no real ethics violation

complaints submitted in ten years, with the exception of a question requiring determination. Councilman Holdridge opined that they may not be submitted due to the process or the Board involved.

Councilman Holdridge made a motion to the floor to direct the attorney to draft a local law to address the matter. There was no second to the motion. The matter was tabled.

BROCOLLI PATCH WATER MAIN EXTENSION

Supervisor Valentine said he was in receipt of the plan and letter from the project engineer to re-route the water main that dead ends at Creamery Pond Road. He said this is problematic with the water main that creates stagnant water that increases organics. Supervisor Valentine has been in contact with the town engineer to work with plan designer to reroute to back of SLPAC parking lot to the end of the water main at Creamery Pond Road. As this is part of a bigger plan to bring water down Kings Highway, the water department placed a stub for fire suppression. He said there will be no action on that tonight as we are waiting on redesign. The Town is in the process of acquiring the road from the County and since approved by the County Exec, it is now in legal review. He said we can then take the main through Sugar Loaf and bring the loop to the front. Councilman Holdridge asked if it is a stipulation of Planning Board approval. Supervisor Valentine said the Town has granted approval for an outside water agreement but is not fully executed, awaiting plans. He added the loop is part of an integral design from 1996 never completed.

1360 KINGS HIGHWAY

Supervisor Valentine addressed the County's taking of Scotts Meadows on back taxes. The 26 acre lot has been subdivided with two buildings sitting on a ½ acre. The Town has the option to purchase said lot for back taxes less fees and penalties for a cost of \$149,926.34. He said this is a big score for the Town since it has a multitude of uses, which could be torn down for parking or create a welcome center for the Chamber and public restrooms.

ON A MOTION OFFERED BY Councilwoman Smith and second by Councilman Holdridge to approve the transfer from reserve funds in the amount of \$149,926.34 for the purchase of 1360 Kings Highway, which may be targeted for AARPA.

DOG PARK DISCUSSION

Supervisor Valentine discussed the Pond Road property being considered for a dog park which would include 7,000 s.f., (40x156) area as low impact with 100ft. buffer flagged by DEC not requiring permits, required grading and fencing, and allow for parking with road frontage.

Engineer's Development Report

- 1. Greens at Chester: SWPPP working well. Discussing Transportation Corporation with developer and getting ready to do the submittal to Orange County. Waiting for mapping from developers Engineer.
- 2. Capelli Sports (Primo Sports): we have a monthly SWPPP which is acceptable.
- 3. Contacted NYSDEC on the dog park. We have developed a sketch of an area that doesn't need a permit if we require a deeper area then we will need NYSDEC permit. See attached.
- 4. Chester PAC CDBG: Rebid soon hope to have ready for next meeting's action. We had 6 contractors at the Pre-Bid.
- 5. Working on MS4 outfalls.

- 6. Reviewing Health Department approval for 10" DI water line through PAC. Request changes from design submitted.
- 7. Game Time "Grant" is a discount not a grant. Must be authorized with deposit by October 27, 2022. They are not on the state bid as we cannot provide them within the next 2 weeks, maybe next year. Their equipment looks interesting for the site.

Police Department – September 2022

The Town of Chester Police Department remained active in the community last month. We continued to take a proactive stance towards detecting crime and enforcing the laws, while maintaining our overall objective of community commitment. In September, the police department responded to 268 calls for service. Officers patrolled for 15,508 miles during the month. COMMUNITY POLICING

During the month, Town of Chester police officers assisted members of the community in many ways. Some of the community policing activity is listed below.

Officers completed no house security checks and 1282 business security checks.

There were three child passenger safety seat checks conducted by our officers in September. Sergeant Dugan and Officers Bird, Weinstein, Stack and Narain continue to remain available for child passenger safety seat checks and installations. Officer Narain also participated in a safety seat checkpoint on September 17th in Kingston that was required to maintain her certification.

TRAINING

All officers except PO Weinstein attended mandatory training at the Senior/Recreation Center on September 13th. The training included the PESH mandatory topics of Sexual Harassment awareness, Right to Know, Response to an Active Shooter, HazMat awareness refresher, as well as Stop the Bleed and AED overviews.

Officer Dunlop and K-9 Lou attended their monthly K-9 training on September 15th.

Chief Doellinger attended training sponsored by the Mid-Hudson Association of Chiefs of Police in Contemporary Issues in Law Enforcement. It was presented by attorneys Lance Klein and Jacqueline Goldberg in Poughkeepsie on September 22nd.

Officer Calderone assisted with firearms instruction at the Basic Course for Police Officers training at the Port Jervis range on September 29th and 30th.

MISCELLANEOUS

Commercial vehicle enforcement details were held on September $_{2^{\circ}d}$ and 16^{th} with the NYS Department of Transportation. Fifteen vehicles were inspected and four unsafe vehicles were taken out of service with major violations.

Chief Doellinger attended the annual community 9/11 Remembrance Ceremony hosted by the Chester Kiwanis. The event was moved indoors to St Columba Church this year due to rainy weather.

Officers provided foot and UTV patrols during Chester Varsity football games at the Chester Commons Park on September 9^{th} , 16^{th} and 24^{th} .

Part-time Police Officer Christopher Donato completed his field training on September 4th. Part-

time Police Officer Nigel Balgobin continued his field training in September.

Full-time Police Officer Katiria Narain continued her field training in September.

Full-time Police Officer Alexandra Gundermann started her field training on September 27th.

A letter of thanks was received from the City of Newburgh police chief for our response to a major incident in the city on September 30th. Officer Deluca responded to the scene to assist with the Tactical Response Unit.

As you know, Friday night we had a shooting with multiple victims at NFA Main campus, as the Football game versus Warwick High School was letting out. It was an extremely stressful and chaotic incident for our agency to handle especially a day after we had a 5-year old shot in the crossfire as an adult male was murdered. I was beyond impressed with the regional response and the support many of your agencies provided; we had over 100 personnel on-scene representing law enforcement, (15) K-9 teams, emergency management, and emergency medical services. I especially want to recognize Chief John Rader who met me on-scene and stayed with me for the duration of the event.

The footprint that had to be secured was enormous, the area to be cleared was equally large and the canvassing for evidence and witnesses was a monumental task to say the least. We were beyond stretched thin with our resources and could not have physically done this alone. Additionally, some of our officers were freed up from the scene once it was contained to answer calls for service. One of those CFS included a 'man with a gun' which resulted in a foot pursuit and recovery of a loaded gun.

It has been clear since the Police Commissioner and I've been here in the City of Newburgh, that when we call for help it doesn't matter what patch is worn or what is says on the side of the police car, you and your agencies respond! Truly humbled by your continued support and beyond proud to serve as member Orange County Law Enforcement family.

Animal Control Report

Highway Department

Milling is complete in Sugar Loaf Heights. The paving has begun and are hoping to be finished no later than Thursday, the 13th.

Crack filling will be performed on some of the roads starting the last week of October. Catch basins are being inspected and repaired as necessary. Drainage is continually being monitored and new pipes are being installed.

The 2023 budget meeting was September 6th. As we discussed at that meeting, we would like permission to issue a P.O. to order a replacement truck for the 1997 International that has frame issues.

Assistance continues to the Water Department for water break issues and project support, such as Fox Hill Rd and well roads.

Leaf season is around the corner! The Highway Department will officially start picking up leaves on October 24th and will conclude on December 2rd. Leaves should be piled curb side, not in the road, and un-bagged. Please do not put sticks, branches, rocks or debris in the piles. This will damage the leaf machine. This service is dependent upon the weather.

Water Administrators Report - October, 12 2022

We are continuing to move forward with improvements to the back-up well at the Sugarloaf water district. Also, at Sugarloaf we still have to finish locating the water main that goes to Pewter Circle from the pump house so an easement can be finalized.

Councilman Holdridge asked about the Chamber of Commerce Fall Festival transportation matter. Gary from the Sugar Loaf Chamber addressed the Board with his request to reimburse half of the total cost of \$1,575.00 for bus transportation from the parking area on Bellvale due to the scheduling conflict at the SLPAC. He requested to avoid this in the future, that his submitted dates of booking be confirmed. Supervisor Valentine asked him to email Walter and copy him to confirm.

TOWN BOARD COMMENTS

Supervisor Valentine commented that he received a distress call from Ken Delmonico of Mobile Life concerning derogatory comments posted on social media and as a result was instructed to remove the ambulances and staff from the Town of Chester. He told Mr. Delmonico the comments are not the opinion of the Town Board and asked that Mobile Life reconsider their decision. Supervisor Valentine explained that since 2014 when the VAC disbanded with a 20% response rate the agreement, at no cost in lieu of space and electricity, was entered into with Mobile Life. He added that the current overbilling issue was not intentional but due to glitches in the billing caused by State changes. He reported that Mobile Life has responded to 745 ambulance calls to date in Chester, at an average response rate of 10.15 min. for emergency and 14.2 min for non-emergency calls. Councilman Courtenay said the isolated incidents of long wait time is not indicative of their overall service. Councilwoman Smith stated that the perception of some people who are anxiously awaiting an ambulance can make two minutes seem like ten. Supervisor Valentine addressed the comments made by Councilman Holdridge on his FB page, as liaison, to look into the billing matter and have residents call him directly with complaints as he is open to changing services. Councilman Holdridge said the posting addressed the news situation and said he would look into and get back to residents about the story, but was not yet prepared to report on the matter with the Board. He added it was a perfectly reasonable response with no definitive statements made and no sole power over Mobile Life as it is completely up to the full Town Board to pull out. Councilman Courtenay said his actions were reckless and the comments would put the residents in jeopardy if Mobile Life were to pull the ambulances out of the Town. He stated Councilman Holdridge, once again, made a decision not based on facts and any comments he received should have been shared with the Board. Supervisor Valentine read the post by Councilman Holdridge on his Town Councilman Facebook page, but assured the residents that Mobile Life will continue to service the Town. He added that the service they provide has been exceptional with staffing and new ambulances and fly cars stationed around the clock at Town Hall.

Councilman Ardisana said he agreed with the comments made that in an emergency we wouldn't want to be short on ambulances and with this service we are covered.

Councilwoman Smith announced the bus trip to Lancaster on October 19 & 20, 2022, the Bellvale Fall Fest at 2pm on October 15th and the Chester Fire Department breakfast at Walton Hose on October 30 ahead of the Halloween Parade.

Councilman Holdridge said he was at the Chester Academy to register 21 new voters. He was happy to report the repaving of 17M at the bridge after the Town Board complained on two separate meetings with DOT. He added it was nice that it was done without any construction planning. He asked for Christmas decorations for the Sugar Loaf Community Foundation to help defray expenses. He announced he has helped at the Chester food pantry and asked others to consider helping if they have the time. He thanked Al Fusco for the good plan drawn for the dog park, and thanked Supervisor Valentine for implementing the dog park.

Supervisor Valentine set he met with the DOT a half dozen times over the 17M bridge who said it couldn't be milled or paved but now, 30 days before an election, it is done. He said it is wrong and a mistreatment of the residents of Chester.
