Brief Description of Proposed Action:  Proposed gravel staging yard for self storage pods. Yard is to be utilized by iCan vehicles moving and storing pods for customers. Customers will generally not visit the property. There will be no office or bathroom facilities. Space for up to 40 - eight foot wide by 16 foot long pods will be provided. The area will be fenced with a chain link fence and automatic gate. A minimum level of security lighting will be provided. Access will be by means of an paved entry road onto Kings Highway (County Route 18) The total area of site disturbance is computed to be approximately 0.85 acres.
