



The billboards have site plan review and approval by the planning board. The Town sign permit will be obtained before installation or modification. The billboard owner will file with the permit application a certificate of insurance certifying the

installation or modification. The billboard owner will file with the permit application a certificate of insurance certifying that the applicant is insured against bodily injury and for property damage arising out of the erection, maintenance, repair and replacement of the billboard. The applicant will maintain said insurance and keep a certificate of insurance currently effective on file with the Town so long as the billboards are in existence. The certificate shall provide that the Town shall receive 10 days written notice in case of cancellation of the policy. Any billboard in violation of the insurance requirements of this section shall be removed immediately and the cost of such removal shall be charged against the owner of the billboard.

(11) The Town may place, at no cost, public service messages up to 5% of the yearly sign time for each sign per year at the me chosen by the Town.

(12) Billboards must otherwise comply with all other relevant regulations of the Town. The Town engineer and the Building Inspector will enforce this subsection.

(13) The fines for violations of this order shall be up to \$1,000 per day as set by the court.


