Julie BELL: Why does he want this this fence so high?

Rommel LASSO: He constructed it himself, it's to be used as a canvas in the inside of the fence. That's why

the height was chosen. It's not a standard fence. **Tom ATKIN:** The property line is farther away.

Dan DOELLINGER: Do you know why it can't be more than feet

JB: How close to neighbors? This could be an issue for the Public Hearing. Where is he?

Rommel LASSO: He couldn't make it.

Counsel DICKOVER: Pics on sheet 1 of 3 – Fence 81 ½ inches above graded floor.

Rommel LASSO: It's a 9 ½ inches over the town code.

Counsel DICKOVER: With respect to the neighbors what is to the right & left. Property yard on left, Right

is the driveway. How far is the neighbor on the right from the fence?

Rommel LASSO: At least 45 feet, not quite sure.

Counsel DICKOVER: Neighbor on the left, the distance from the fence? 37.5. Are there any other houses

in the area that have fences that exceed 6 ft.

Rommel LASSO: Not that I can see.

Counsel Dickover: Is it possible to bring the fence down to 6ft, and if not why.

Rommel LASSO: We could cut it down but the murals and canvas would interfere.

Rommel LASSO: The canvas is inside.

Counsel Dickover: What will the finish be? What type? You need to have a conversation with the

Building Inspector about the color/black in a residential zone.

Rommel LASSO: States the client said the Building Inspector may have known it was going to be black.

Dan DOELLINGER: Are we ready for a Public Hearing?

Counsel DICKOVER: If they are going to propose a solid wood fence 8 ft high, I think we should maybe

confer with the Public Hearing.
